A. Doug Schultz, ROWE - SPARK Grant

Imlay City received multiple bids for Lions Park. The city has received approval from CMF to award the bid to T.G. Priehs, LLC for a total of \$699,029.40. CMF awarded an additional \$20,000 to the budget resulting in a \$1,000 contingency fund.

Construction at Lions Park would begin late fall of 2025. Final completion date is April 1, 2026. A meeting with the contractor will be scheduled to finalize the awarding of the contract as bid.

As per previous discussions, if the FitCore equipment is eliminated from the bid, it would save \$40,000. CMF would want a replacement feature if the FitCore is not pursued. ROWE prepared plans that included a swingset and other small features in the space of the FitCore. The commission believes replacing FitCore with the new features would be the best course of action. Doing so would save an additional estimated \$20,000. Doug Schultz explained that a change order can be submitted after awarding the contract.

If paved paths were pursued, it would increase the base bid by \$78,505. With \$20,000 savings from replacing the FitCore (if replaced), the commission discussed possible fundraising options for the remaining \$58,505 if paving is pursued.

Ribbon cutting ceremony estimated to take place late September or early October.

B. Amend the Parks and Recreation Master Plan

- i. Downtown Depot Pavilion Amending the Master Plan to include the Downtown Depot Pavilion requires a public hearing. The pavilion may already be included in the Master Plan as part of Lamb Steele Park.
- ii. Old DPW Building Discussion
 Amending the Master Plan to include the Old DPW Building requires a public hearing.
