# 2018 Summer Newsletter

### FROM THE DESK OF TOM YOUATT, CITY MANAGER

This summer will be a busy one in the City of Imlay City this year. The City has some important projects that are planned and will be under construction soon.

The City is fortunate to see a 40 unit Assisted Living facility coming to the City. In order to provide utility service to the site of this facility, which is located on South Almont Avenue between Newark and Borland roads, the City will be constructing a new sanitary sewer main to serve this project. In order to bring development to the City, including the addition of jobs and tax base, the City needs to provide necessary utilities to vacant properties located in the City. This project includes the replacement of an undersized sanitary sewer main with a larger main and also extension of the existing main along S. Almont to the site. The work will begin in June and completed by end of summer.

Another project the City will undertake is the reconstruction of East Capac Road from M-53 east to the City limits. This will complete a stretch of Capac Road that the Lapeer County Road Commission started last year. This project will begin soon and will be completed by Labor Day weekend.

The City has been planning for construction of a much needed new Fire Hall for the City. The City has purchased the former DNR property along Borland Road near M-53, which is an ideal, central location for a Fire Hall. The City is asking citizens to support issuing General Obligation Bonds for this project in the amount of \$3,000,000. To support these bonds, the City is seeking to levy about 2 mills over 20 years to pay for this much needed facility. The proposed issuance of bonds will be on the ballot this coming August primary election. There will be open houses scheduled soon at the Fire Hall on 3<sup>rd</sup> Street so citizens can see the need for a new facility.

Finally, the City will is excited to see the construction of the M-53 Gateway project. This project will be located on M-53 and will include construction of a new boulevard with flower and grass plantings, a new Imlay City sign, and decorative LED streetlights from Newark Road south. With completion of this project this summer, the City expects that this will calm and slow down traffic while providing an improved image of our City.

The City wishes everyone a safe and fun-filled summer!

There are two Elections for the residents of Imlay City:August 7, 2018State PrimaryNovember 6, 2018State General Election

The last day to register to vote for the August Election is July 9, 2018

The last day to register to vote for the November Election is October 9, 2018

You can Register to VOTE at the Imlay City Clerk's Office, the Lapeer County Clerk's Office, any Secretary of State's Office, or by mail.

You may be eligible to VOTE by mail with an Absentee Ballot if you meet any of the following Eligibility Requirements are as follows:

Is 60 years of age or more

Is unable to vote without assistance

Expects to be absent from his or her city or township of residence for the entire time the polls are open Is in jail awaiting arraignment or trial

Has been appointed to work as an election inspector in a precinct outside of his or her precinct of residence Is unable to attend the polls due to his or her religious beliefs

If you qualify and wish to Vote by Absentee Ballot, Please contact the Imlay City Clerk's office and an application will be sent to you. Once the Ballots are available (approximately 45 days prior to the Election), you will be mailed a Ballot which can be returned in person or by mail.

## FROM THE DESK OF RICK HORTON, FIRE CHIEF

With the increase in warm weather, we spend much more time outdoors, camping, grilling, and relaxing. Along with outdoor activities comes campfires. Enjoy the outdoors and campfires and please be careful. As everyone should know the Imlay City Fire Department is in the process of building a new fire hall, we are in the process of planning an open house of our old fire hall so the public can tour the existing quarters, and see drawings of planned new structure. During the Busker Festival and during the Farmers Market we will try to have personnel available at existing fire hall for tours and to answer questions. As always the Imlay City Fire Department is interested. Be safe and enjoy summer!

#### FROM THE DESK OF ED PRIEHS, DPW SUPERINTENDENT

In 2014, the City purchased a brand-new Elgin Pelican Street Sweeper for the DPW. It replaced an aging 1994 same style street sweeper that had increasing maintenance costs and decreasing efficiency. Street sweeping is an important part of Public Works operations for many reasons other than just improving the appearance of a city. Street sweeping removes litter, sand, loose gravel, soil, dust, vehicle debris and pollutants, de-icing chemicals, and other debris in order to prevent these materials from being washed into storm sewers. When done regularly, street sweeping can remove 50-90% of street pollutants that can enter surface water through storm sewers. It reduces catch basin and storm sewer maintenance and will also make street surfaces less slippery in light rains. Residents can help by avoiding parking on streets during the day time or moving vehicles off the street when the street sweeper is in the neighborhood. Do not dump hazardous materials into catch basins and please do not blow grass clippings or



debris onto streets that could enter or block catch basins. With a combined effort, help protect surface water, minimize potential local flooding, and keep streets clean and safe.

#### FROM THE DESK OF PATRICK RANKIN, WASTEWATER SUPERINTENDENT

One of the biggest costs to running a wastewater plant is electricity. We have a lot of pumps, mixers, disinfection units, blowers and air compressors, lights and heating units, all using plenty of electricity. Averaging 1600 to 2100 kwh per day depending on the season. We do all we can to not waste electricity by keeping equipment well maintained, and using proper run times and speeds, but we will always have a high consumption of electricity, it's just the nature of the industry. One thing most people don't know about the plant is that it's mostly gravity fed, meaning we have one pump that lifts the water from sewer level and then gravity will take it through the plant to discharge.
