or similar private sewage disposal facilities shall be abandoned and filled with suitable material if its construction is such that it may endanger life or property through deterioration and collapse. (8/27/58)

Section 303: The owner shall operate and maintain the private sewage disposal facilities in a sanitary manner at all times at no expense to the City of Imlay City.

Section 304: No statement contained in this Article shall be construed to interfere with any additional requirements that may be imposed by the City Commission or by the SWRC.

ARTICLE IV - BUILDING SEWERS AND CONNECTIONS

Section 401: No unauthorized person shall uncover, make any connections with or open into, use, alter, or disturb any public sewer or any appurtenance thereof.

Section 402: All costs and expenses incident to the installation and connection of the building sewer shall be borne by the owner of said property. The owner shall indemnify the City of Imlay City from all loss or damage that may directly or indirectly be occasioned by the installation of the building sewer.

Section 403: All applicants for sewer connections shall first submit plans and specifications of all plumbing construction within such building or premises, and such plans and specifications shall meet the requirements of the State Plumbing Code and all provisions, rules, and regulations of the SWRC or its affiliates. When such plans and specifications have been approved by the City Manager and/or the City Plumbing Inspector of the City of Imlay City, a construction permit shall be issued, subject to a final inspection and approval when construction is completed and ready for connection with the sewer system. (1/13/82)

Section 405: The applicant for a building sewer permit shall notify the Plumbing Inspector of the said City of Imlay City when the building sewer is ready for inspection and connection to the public sewer. The Plumbing Inspector or his authorized representatives shall then inspect the said building and plumbing construction therein and if such construction meets previous requirements as approved in the construction permit, the Plumbing Inspector of the said City of Imlay City shall issue a sewer connection permit, subject to the provisions of any other ordinance. ARTICLE V - USE OF PUBLIC SEWERS

Section 501: No person shall discharge or cause to be discharged any storm water, surface water, ground water, roof runoff, subsurface drainage, cooling water or unpolluted industrial process waters to any sanitary sewer.
