## 6. CITIZENS FROM THE FLOOR

Stu Davis - Mr. Davis stated that it has been 15 months since he asked for restoration reform to be placed on the agenda. Stated that a system is needed so that the business owners understand what their liabilities are, what the time frame is. We need regulations to stop them from leaving the business's in bad condition. The City needs an ordinance to address these issues.
Mayor Kempf stated that there was discussion on this issue at the last City Commission meeting. Ian Kempf read the minutes to Mr. Davis. Kempf suggested we look for sample ordinances. He also questioned why our City Planner is not at the meetings so that these issues could be discussed with them. He would like to see a planner at every meeting. The rate to have the Planner at the meetings could be built into the fees or have an hourly rate.
Mr. Davis suggested we hire an engineer for discussion about this issue to the City Commissioners. Mayor Kempf will speak with the City Manager about the City Planner being in attendance.

He also stated that vehicles at the back are not seen by passersby. He would like to add 10 parking spots at the rear Southwest corner of his lot and 10 parking spots in the front Northwest corner of his lot. He stated if the front 10 parking spots were a concern, he would withdraw the request for those.
