From the City Manager's Desk

What an early start to winter this year! Record snowfall and colder than average temperatures has had an impact on City operations and projects.

Our new Fire Hall construction project on East Borland (behind Taco Bell) has slowed down due to the weather. We are hoping for an improvement in temperatures and clearer days near the end of November so we can see the building enclosed and work proceed on schedule. At this time, we are looking at completion at the end of January if all goes well. The new Fire Hall will be a facility that all of us in Imlay City can be proud of!

The City is also looking forward to making some much needed improvements to our infrastructure. MDOT is planning on resurfacing the entire stretch of M-53 in the City in 2021. As such, we have a critical sewer main replacement project on M-53 from 4^{th} Street all the way to the Wastewater Treatment Plant which needs to be completed by this coming summer. As part of this project, the City plans on a complete infrastructure replacement on 4^{th} Street from M-53 to Main Street. This will be the first phase of infrastructure replacement on 4^{th} Street from M-53 to Blacks Corners Road.

Another exciting project for the City this year is construction of a new Splash pad. The City has applied for grant funding from the MDNR in the amount of \$ 150,000 and we are cautiously optimistic we will receive this grant. Construction of the new Splash pad, adjacent to the City's Pool, would begin this next Fall.

With winter weather already here, the City reminds our residents to be careful driving and to watch out for our DPW plow trucks and crew as they work hard to keep our streets clean and clear of snow.

Finally, the City wishes everyone a safe and Happy Holiday Season!

2020 brings us three Elections beginning with the Presidential Primary March 10, followed by August 4^{th} , and the General Election November 3^{rd} .

All Registered Voters can now vote by Absentee Ballot. Call the City Clerk if you would like to be placed on the Permanent Absentee Voter List. Once on the list, you will automatically be sent an application for each election. Complete and return the application and a ballot will be sent to you a month prior to the election. If you would like to vote at the polls, just don't return the application.

It's that simple.
